

ProCurve 2810 Mail in Rebate Terms & Conditions (5-Apr-07)

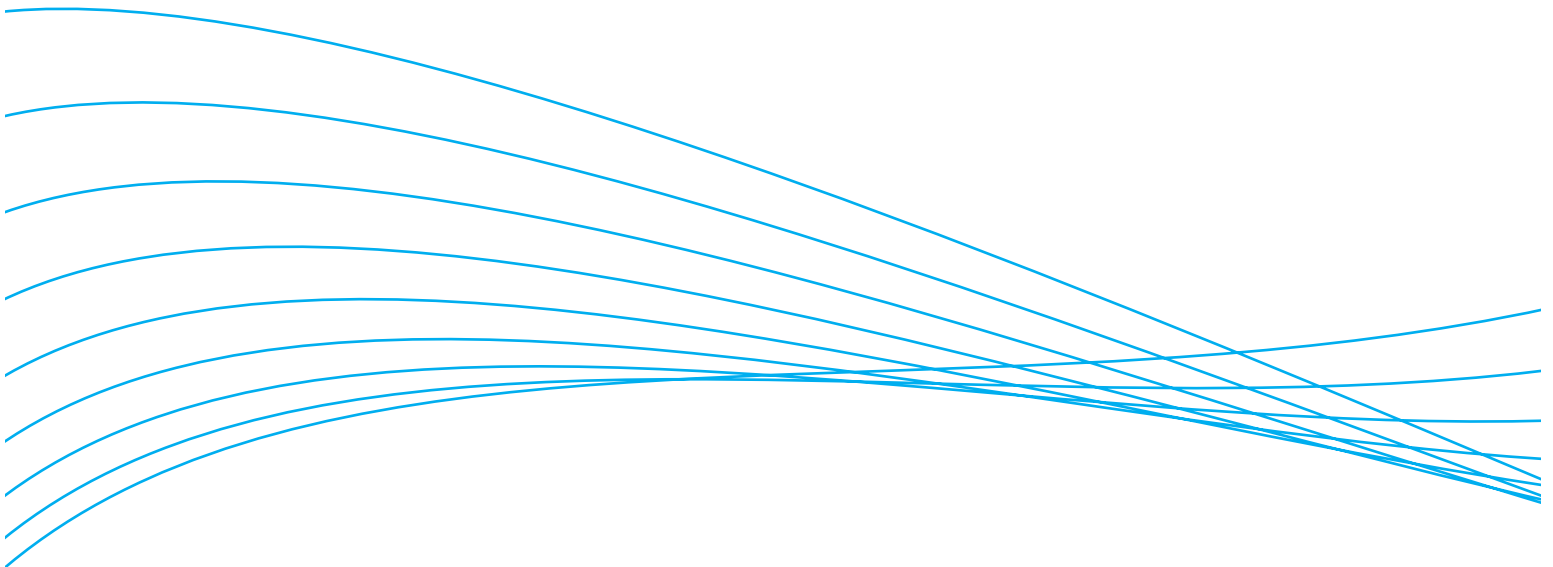
